
# BS, BS2 & BS3 ALL BALANCE SHEET FORMATS

Added right-click menu option to select either single or plural wording in long-term sections




# CA, CB & IA PPE / INTANGIBLE ASSETS WORKING PAPERS





### CORRECTIONS AND ENHANCEMENTS

The following corrections and enhancements were made:

#### **BS** UNCLASSIFIED BALANCE SHEET

√ The right-click section formatting options for the asset section were modified to include line spacing option.

## BS, BS2 & BS3 ALL BALANCE SHEET FORMATS

- ✓ Where notes are not being used and entities are defined, lines linked on mapping that separate debit and credit balances (due to/from related party, due to/from shareholders, and income taxes) now do so on individual accounts rather than entity totals.
- ✓ Corrected an issue in these modules causing a NIL balance for short-term debt when short-term debt notes Option 1 or Option 2 are used.

#### **CF** STATEMENT OF CASH FLOWS

- ✓ Corrected an issue in the investing activities section where the where note references were inconsistent.
- Corrected an issue which was causing "excess of revenue" to be displayed, instead of "Excess of revenue".

#### CF2 9 COLUMN CASH FLOWS WITH BUDGET

- ✓ Corrected an issue in the browses for current and prior period total balances for non-cash working capital.
- Corrected issue with prior period total for non-cash working capital when multi-columns were selected.

#### **CP** HOME MENU

- ✓ Corrected an issue where minimizing the freeze frame caused the column settings area to be hidden.
- ✓ Home menu now shows a firm designation selector if firm continues to use the old RD firm profile module in their Resource Centre.

#### DI DEFERRED INCOME WORKING PAPER

Replaced an incorrect map number used in the diagnostics area of the working paper.

#### IS2 9 COLUMN INCOME STATEMENT

✓ Corrected an issue where the Gross profit % was not displayed when only a single item in the COGS section.

#### JZAL ACCRUED LIABILITIES WORKING PAPER

✓ Corrected an issue preventing the footer from loading.

#### JZEL ENGAGEMENT LETTER

- ✓ Updated the wording of the Objective and Scope paragraph, which was incorrectly referring to Financial Statements, when set to Corporate tax return only".
- ✓ Updated the wording of the opening paragraph to refer to both years when the letter is set to "Corporate tax return only" and "Current and prior period" is selected.

#### RP & JZEL ENGAGEMENT REPORT & ENGAGEMENT LETTER

- ✓ Added missing period at the end of the "Opinion" and "Conclusion" paragraphs of the Report and the Sample Report in the letter, when engagement set to "Modified Qualified opinion/conclusion" or "Modified Adverse opinion/conclusion".
- ✓ Modified the formatting of the wording referencing the accounting standard used for the engagement, for example "Canadian accounting standards for private enterprises (ASPE)" instead of "Canadian Accounting Standards for Private Enterprises (ASPE)". This is consistent with the Handbook and CPA model financial statements.

#### **SC** SCHEDULES MENU

✓ Corrected an issue with schedule 2 where the positioning of "(continues)" was inconsistent when a carry-forward was triggered in the schedules.

#### **SC1** INCOME SCHEDULE

✓ Corrected an issue with underling multiple inserted subtotals.

# SC2, SC6 - GENERIC 9 COLUMN SCHEDULE, 9 COL INCOME SCHEDULE

✓ Improved the way the period selectors function when selecting periods other than the default set via the CaseWare Context option.

✓ Corrected an issue where currency symbols were displayed in the carry-forward column headings.
